

# Tennessee Valley Kennel Club - July 16, 2013

The general meeting at the Animal Emergency Center, Kingston Pike, Knoxville TN at 7:43 PM following a dog fanciers' version of Family Feud by President Walter Sommerfelt. There were 20 members + 1 guest.

The minutes were approved as read.

**PRESIDENTS REPORT** – Wally explained that since the last meeting the board had selected Judy Hart to attend the Canine Health Foundation bi-annual conference in St. Louis area.
