This constitutes an Agreement between the Tennessee Valley Kennel Club, Inc., hereinafter referred to as the "Club" or "TVKC" and _____ hereinafter referred to as the "Judge" as follows:

The Club will attempt to fulfill special requests. However, not all requests may be possible, due to circumstances beyond the Club's control.

Expenses:

1. **EITHER/OR:**
 - a. **Airfare & Transportation:** coach airfare, airport parking, transportation to and from airport.
 - b. **BY MOTOR VEHICLE:** the current (to the year of the event) publicized Internal Revenue Service applicable mileage rate will apply.
2. The Club will arrange hotel lodging which will be **paid by the Judge and then reimbursed.**
3. The Club provides a luncheon on the date of the assignment(s) and will expense a maximum of \$35.00 (thirty-five) U.S. dollars per day to the Judge for food allowance.
4. Copies of course maps (if applicable) equivalent to Kinko's \$ per copy rate.

Exclusions:

Reimbursements shall not include the following or by analogy any of the following personal expense:

- Alcoholic beverages/bar expense - Telephone calls, movies, etc.
- Kennel assistance, house sitters - Travel agent fees
- Dry cleaning and any other incidental costs not approved by the Club in advance.

Conditions:

Airfare: Considering Judges are requested to adjudicate approximately 1 (one) year prior to their assignment, the Club shall pay for reasonable airfare expenses provided that the Judge acted in a prudent manner and purchased the ticket within a time frame that reserved and acquired the best possible airfare price, but at least 21 (twenty-one) days prior to their departure date.

Cancellations:

If for any reason whatsoever the Judge cancels their attendance to adjudicate the assignment this agreement shall become null and void and the judge shall not be entitled to any compensation save and except for provisions within this agreement. In this event the judge shall hold the Club and any of its members or any associated wherein harmless for any damages that may have occurred due to the cancellation by the judge.

However, in the event of any unforeseen cancellations by the Club for reasons beyond their control (e.g. inclement weather, acts of nature or acts of God) and any other cancellations wholly at the initiation of the Club shall result in the Club compensating the judge for reasonable airfare incurred solely to attend their assignment. In such an event the Club reserves the right to pay the non-refundable difference of airfare tickets in rescheduling the event to another date to be announced at the earliest possible time after cancellation.

Additional Expense to be Approved:

The Club reserves the exclusive right to receive and compensate the judge for any additional expenses, whatsoever, that may be submitted by the judge in a Supplemental Invoice, with sufficient proof, as deemed by the Club, by which such invoice shall be submitted within 60 (sixty) days of the date of the event (and/or cancellation date by the Club).
